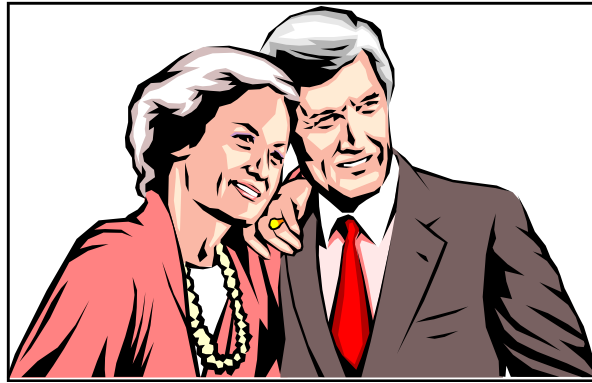
1. A High School Diploma – or better.

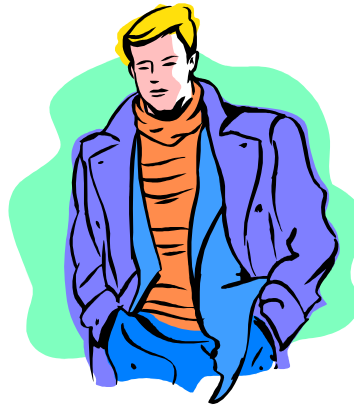
